UCT OHS OER TERMS & CONDITIONS

This Agreement ("Terms") sets out the terms and conditions that govern your use of the UCT Online High School's Open Education Resources ("OER"). As some of our OER may be software that is downloaded to your computer, phone, tablet, or other device, you agree that we may automatically update this software, and that these Terms will apply to such updates. Please read these. By agreeing to these Terms and making use of our OER, you consent to the following policies, applicable to, and accessible on, our websites (including the Website and other such URLs that we may indicate from time to time ("Website(s)")), which are incorporated by reference into these Terms: Website Terms of Use and any other policy as is made available on our Websites from time to time ("Policies").

Using UCT OHS OER

Who May Use our OER

Unless indicated as being in the public domain, the OER provided by UCT OHS are protected by copyright law, and may be used by any individual provided it is for their own personal use. By making use of UCT OHS' OER you agree to retain all copyright and other notices on any content you obtain from the UCT OHS OER Site. Any use or access by anyone under the age of 18 must be with the assistance and consent of said person's parent or legal guardian.

No affiliation with learning centres

Whilst we recognise the importance of collaboration and partnership in the education space, UCT Online High School is currently not in a position to collaborate or partner with any learning centre, tutoring organisation and non-governmental organisation.

At present, any centre that supports learners regularly, by offering augmented support at a specific facility is legally required to register as an independent school. Of concern to us is that most centres choose not to do this as they cannot comply with the associated regulations that apply to traditional brick and mortar schools. And UCT Online High School has no control over this issue. In any event, and unlike these learning centres, our education model is slightly different and way ahead of the current regulatory regime.

The mere fact that we make Open Free Curriculum accessible to every learner, including learners who are not registered with UCT Online Home Education should not be interpreted to mean that those learners or their institutions are affiliated with UCT Online High School. It should be noted that learners who sign up for our Open Free Curriculum are not registered with UCT Online High School. As such, we will not take any responsibility for their learning outcomes and cannot provide School-based Assessments or report cards for these learners.

Our Licence to You

Subject to these Terms and our policies we grant you a limited, personal, non-exclusive, non-transferable, and revocable licence to use our OER. You may download content from our OER Site only for your personal, non-commercial use, unless you obtain our written permission to otherwise use the content. Using our OER does not give you ownership of or any intellectual property rights in our Services or the content you access.

Content Offerings

Changes to OER Content

The content of UCT OHS' OER is the same as that used for students formally enrolled with UCT OHS. UCT OHS reserves the right to cancel, interrupt, reschedule, or modify the content of the OER at any time.

Lodging a complaint

We will strive to ensure that anyone giving feedback does so with the utmost courtesy and respect, and in return, we expect that anyone giving feedback or making a complaint will do so fairly and appropriately. Where we determine that a complaint is abusive, unreasonable, or an individual is unreasonably pursuing a complaint that has previously been investigated, we reserve our rights in relation to our response, and in particular, may elect not to pursue the procedure set out below.

Review and investigation

Once a complaint has been lodged, we will investigate and attempt to address the matter in
